The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum of **Twelve Million Eight Hundred Twelve Thousand Eight Hundred Ninety Pesos Only (12,812,890.00)** for the **PROJECT 2019-14: Construction of 300cu.m. Elevated Steel Tank.**

Location of Project : MSU Compound, Brgy. Fatima, Gen. Santos City

Brief Description : The work consists of furnishing of all the required labor, equipment, tools, scaffolding, services and materials up to the contract limit for the completion of the proposed project.

Approved Budget for the Contract : **Php 12,812,890.00 (VAT Inclusive)**

Source of Fund : **CAPEX 2019**

Contract Duration : **150 CALENDAR DAYS**

The GSCWD now invites Bids from eligible Bidders for the **Project 2019-14: Construction of 300cu.m. Elevated Steel Tank to MSU Compound, Brgy. Fatima, General Santos City.** The effective date of the Contract is the receipt of Purchase Order.

Bidding will be conducted through competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.
