INVITATION to BID

Project 2020-04: Construction of 1,000cu.m. Cylindrical Ground Steel Tank

The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum of **Nine Million Fifty Thousand Pesos Only (9,050,000.00)** for the **PROJECT 2020-04: Construction of 1,000cu.m. Cylindrical Ground Steel Tank.**

Location of Project : Circumferential Road, Prk. Udagre, Brgy. Conel,

General Santos City

Brief Description : The work consists of furnishing of all the required labor, equipment, tools, scaffolding, services and materials up to the contract limit for the completion of the proposed project as specified herein:

- a. The Contractor shall build 1,000 cubic meter cylindrical steel tank where necessary piping and other appurtenances shall be in accordance with the approved plans and specifications.
- b. Perform excavation on any type of soil and backfilling using suitable materials and disposal of undesirable surplus materials where directed.
- c. Installation of pipes, fittings, closure pieces, supports, bolts, nuts, gaskets, jointing materials and appurtenances as shown and specified and as required for a complete and workable piping system.
- d. Flushing, leak testing and disinfection of the Steel Tank.
- e. All steel pipes and valves are supplied by the owner.
- f. The Contractor shall fabricate needed fittings and other appurtenances such as steel flanges.

Approved Budget for the Contract : Php 9,050,000.00 (VAT Inclusive)

Source of Fund : CAPEX 2020 (Early Procurement)

Contract Duration : 210 CALENDAR DAYS

The GSCWD now invites Bids from eligible Bidders for the **Project 2020-04: Construction of 1,000cu.m. Cylindrical Ground Steel Tank** *to Purok Udagre, Brgy. Conel, General Santos City.* The effective date of the Contract is the receipt of Purchase Order.

Bidding will be conducted through competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.
