Project 2021-14: Construction of 1,000cu.m. Cylindrical Ground Steel Tank

The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum of **Nine Million Ninety Six Thousand Eighty Two & 94/100 (9,096,082.94)** for the **Project 2021-14: Construction of 1,000cu.m. Cylindrical Ground Steel Tank.**

- Location of Project : Prk. Cabuay, Brgy. Sinawal
 General Santos City
- Scope of Work : The work consists of furnishing of all the required labor, equipment, tools, scaffolding, services and materials up to the contract limit for the completion of the proposed project.
- Approved Budget for the Contract : **Php 9,096,082.94 (VAT Inclusive)**
- Source of Fund : **CAPEX 2021**
- Contract Duration : **210 CALENDAR DAYS**

The GSCWD now invites Bids from eligible Bidders for the **Project 2021-14: Construction of 1,000cu.m. Cylindrical Ground Steel Tank at Prk. Cabuay, Brgy. Sinawal, General Santos City.** The effective date of the Contract is the receipt of Purchase Order.

Bidding will be conducted through competitive bidding procedures using non-discretionary “pass/fail” criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.

The *General Santos City Water District Bids & Awards Committee* will hold a Pre-Bid Conference on **March 17, 2021, 1:30pm** at the *General Santos City Water District Board Room*, which shall be open to all interested parties.

The General Santos City Water District (GSCWD) assumes no responsibility whatsoever to compensate or indemnify bidders for any expense incurred in the preparation of the bid. Moreover, GSCWD reserves the right to reject any or all bid proposals at any time prior to contract award, waived any formality in the bid requirements, declare a failure of bidding, or award the contract to the bidder whose offer is most responsive, lowest calculated bid, and most advantageous to the government.

All bids must be accompanied by a Bid Security in the form of:
