INVITATION TO RE-BID

Project 2021-27: Purchase of Assorted Sizes uPVC Pipes S-8 & S-10, Fixed Seal

The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum of **Nine Million Nine Hundred Ninety Nine Thousand Six Hundred Pesos Only (Php 9,999,600.00)** for the **Project 2021-27: PURCHASE OF ASSORTED SIZES UPVC PIPES SERIES 8 & SERIES 10, FIXED SEAL.**

Source of Fund: CAPEX 2021

The GSCWD now invites Bids from eligible Bidders for the *Project 2021-27: Purchase of Assorted Sizes uPVC Pipes S-8 & S-10, Fixed Seal* (225mmØ x 6m uPVC Pipe Series-8, Fixed Seal - 500 pcs - 12.90 - 14.39 thickness (mm); 110mmØ x 6m uPVC Pipe Series-10, Fixed Seal - 1,376 pcs - 5.30 - 6.03 thickness (mm); 90mmØ x 6m uPVC Pipe Series-10, Fixed Seal - 1,400 pcs - 4.40 - 5.04 thickness (mm)) *for the pipeline expansion distribution projects of 2021.* Bidders shall be a manufacturer of fixed seal uPVC Pipe for a minimum of five (5) years. The effective date of the Contract is the receipt of Purchase Order.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.

Moreover, GSCWD reserves the right to reject any or all bid proposals at anytime prior to contract award, waived any formality in the bid requirements, declare a failure of bidding, or award the contract to the bidder whose offer is most responsive, lowest calculated bid, and most advantageous to the government.
