#### **Terms and Conditions:**

- I. The winning bidder shall register the vehicle to Land Transportation Office (LTO) with a minimum of three (3) years expiration.
- II. The winning bidder shall secure one (1) year comprehensive insurance from the Government Service Insurance System (GSIS) with the inclusion of Acts of Nature (AON), theft and on damage.
- III. The winning bidder shall provide Three (3) years or One Hundred Thousand (100,000) kilometres warranty whichever comes first on the vehicle unit and its accessories. Warranty period shall commence from the date of final acceptance.

- IV. Labor and consumables (e.g. oil and filters) on the first preventive maintenance shall be shouldered by the winning bidder and labor only on the succeeding years of the warranty period.
  - ٧. Markings on the vehicle body particularly the GSCWD official logo, "General Santos City Water District" and "for official use only" shall be provided by the winning bidder.
- VI. The winning bidder shall provide two (2) sets of early warning device (as per LTO standard), one (1) unit spare tire, one (1) unit hydraulic jack and one (1) unit tire wrench.
- The vehicle unit shall be delivered to GSCWD office and shall be within the period of sixty VII.

VIII. (60) calendar days from the date of receipt of Purchase Order (PO).
