The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum One Million Eight Hundred Forty Six Thousand Four Hundred Sixty Four & 32/100 Pesos Only (Php 1,846,464.32) for the Project 2022-20: Construction of CSWDO Perimeter Fence.

Location of Project : CSWDO Compound, Prk. 11B, Brgy. Fatima

Scope of Work : The scope of work of this project consists of supply

and delivery of materials, appurtenances, labor, equipment, tools, power, water consumables, demolition and supervision for the completion of the proposed project as shown on plan and technical drawings specified in the scope of work.

Approved Budget for the Contract : Php 1,846,464.32 (VAT Inclusive)

Source of Fund : CAPEX 2022

Contract Duration : NINETY (90) CALENDAR DAYS

The GSCWD now invites Bids from eligible bidders for the **Project 2022-20: Construction of CSWDO Perimeter Fence** *at CSWDO Compound, Prk. 11B, Brgy. Fatima, General Santos City.* The effective date of the Contract is the receipt of the Notice to Proceed.

Bidding will be conducted through competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.
