## **INVITATION TO BID**

Project 2023-07: Purchase of Assorted Sizes Shop Prime / Cement Lined (SP/CL), Cement Coated / Cement Lined (CC/CL), and Epoxy Prime Spiral Welded Steel Pipes

The General Santos City Water District (GSCWD), through its Bids and Awards Committee (BAC) intends to apply the sum of Six Million Seven Hundred Ten Thousand Pesos Only (Php 6,710,000.00) for the Project 2023-07: Purchase of Assorted Sizes Shop Prime / Cement Lined (SP/CL), Cement Coated / Cement Lined (CC/CL), and Epoxy Prime Spiral Welded Steel Pipes.

Source of Fund: CAPEX 2023

The GSCWD now invites Bids from eligible Bidders for the **Project 2023-07: Purchase of Assorted Sizes Shop Prime / Cement Lined (SP/CL), Cement Coated / Cement Lined (CC/CL), and Epoxy Prime Spiral Welded Steel Pipes** (179 pieces – 4.78 thickness – 250mm x 6m Cement Coated / Cement Lined Spiral Welded Steel Pipes; 18 pieces – 4.78 thickness – 200mm x 6m Cement Coated / Cement Lined Spiral Welded Steel Pipes; 4 pieces – 4.78 thickness – 150mm x 6m Cement Coated / Cement Lined Spiral Welded Steel Pipes; 36 pieces – 4.78 thickness – 250mm x 6m Shop Prime / Cement Lined Spiral Welded Steel Pipes; 36 pieces – 4.78 thickness – 200mm x 6m Shop Prime / Cement Lined Spiral Welded Steel Pipes; 31 pieces – 4.78 thickness – 150mm x 6m Shop Prime / Cement Lined Spiral Welded Steel Pipes; 6 pieces – 4.78 thickness – 200mm x 6m Shop Epoxy Primed Spiral Welded Steel Pipes). The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person. Pipes shall be the product of one manufacturer that has not less than five (5) years successful experience manufacturing pipe in the Philippines of the particular type and size indicated. The effective date of the Contract is the receipt of Purchase Order.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act, and is restricted to Filipino Citizen/s sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during post-qualification procedure.
