

4. That the winning bidder shall have an available qualified and trained technicians 24/7 in case of equipment failure.
5. The winning bidder shall be subjected to Liquidated Damages (LD) for each day of delay as provided by the IRR of RA 9184.
6. That the winning bidder shall issue a warranty certificate of not less than one (1) year and the warranty shall commence from the date of commissioning of the unit.
