3	The winning bidder shall deliver the soft starter motor controllers within Sixty (60) calendar days upon receipt of Purchase Order (PO).	
4	The winning bidder shall be subjected to Liquidated Damages (LD) for each day of delay as provided by the IRR of RA 9184.	
5	That the winning bidder shall issue a warranty certificate of not less than one (1) year.	
6	That the bidder must have an available qualified and trained technicians 24/7 in case of equipment failure.
