4	That during the installation and commissioning of the units, the winning bidder shall be required to send a technician/s responsible of installation and commissioning of the two units. All relevant and incidental cost (transportation, accommodation, allowances and etc.) in the commissioning of the equipment shall be shouldered by the winning bidder.	
5	The lightning arresters and installation must comply with all relevant local, national, and Philippine Electrical Code. The supplier is responsible for obtaining any necessary permits or approvals for the installation.
